Pursuant to the July 5, 2007 Procedural Order in this matter and A.A.C. R14-3-105, the Arizona Investment Council ("AIC") applies to the Commission for an Order granting it leave to intervene in this proceeding. In support of its Motion, AIC states:

1. AIC's missions include the promotion of policies which encourage utility investment and infrastructure development in Arizona as well as representation of the interests of debt and equity investors in Arizona utilities, including its electric utility providers. AIC's nearly 7,000 members include Arizona electric providers and individuals who hold stock or debt instruments in these utilities.

2. This docket involves Sempra Energy Solutions' request for a Competitive Certificate of Convenience and Necessity and, as the testimony filed to date indicates, also presents important policy questions for the Commission in relation to retail electric competition. AIC's members will be directly and substantially affected by the Commission's decision on these matters.


