PROCEDURAL ORDER

**BY THE COMMISSION:**

On June 29, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Leonard Clark Rhodes, Jr. and Margaret Rhodes, husband and wife (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

Respondents were duly served with copies of the Notice.

On July 11, 2007, each Respondent filed a written response, but did not request a hearing.

On July 17, 2007, Respondent Leonard Clark Rhodes, Jr. filed additional documents, but again did not request a hearing.

Under the circumstances, a pre-hearing conference should be held, and if Respondents appear, determine whether it was their intention to request a hearing.


