PROCEDURAL ORDER BY

BY THE COMMISSION:

On September 26, 2006, IElement Telephone of Arizona, Inc. ("IElement" or "Company") submitted to the Arizona Corporation Commission ("Commission") an application for approval of a Certificate of Convenience and Necessity ("Certificate") to provide facilities based local exchange telecommunications services and facilities based long distance telecommunications services in Arizona.

On October 5, 2006, the Commission's Utilities Division ("Staff") filed a Letter of Insufficiency and first set of data requests in this matter.

On November 2, 2006, IElement filed its response to the data request.

On November 9, 2006, Staff filed a second Letter of Insufficiency and a second set of data requests.

On November 22, 2006, IElement filed its Response to Staff's second set of data requests.

On June 6, 2007, Staff filed its Staff Report recommending approval of IElement's application.

On June 27, 2007, by Procedural Order, the hearing in this matter was scheduled for August 15, 2007. The Procedural Order also instructed Applicant to publish notice of the hearing by July 13, 2007, and to file an Affidavit of Publication by July 31, 2007.

On July 16, 2007, Applicant's counsel filed a Request for Continuance ("Request") stating

1 that Applicant is unable to meet the specified publication date and requesting the Commission grant it
2 additional time to publish notice of the hearing.

3 On August 3, 2007, by Procedural Order, the hearing in this matter was continued to
4 September 27, 2007.

5 On August 24, 2007, IElement filed a Request for Continance of the September 27, 2007
6 hearing. IElement's Request stated that its parent company is currently engaged in negotiations with
7 another entity for a possible merger. IElement further requested an additional 30 days leave to
8 complete its merger discussion.

9 IT IS THEREFORE ORDERED that IElement's request for continuance of the hearing in this
10 matter is hereby granted.


11 IT IS FURTHER ORDERED that no further hearing dates shall be set on this matter until
12 IElement files a request with the Commission to have this matter reset for hearing.

13 IT IS FURTHER ORDERED that the timeclock is suspended indefinitely.

14 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
15 Communications) applies to this proceeding and shall remain in effect until the Commission's
16 Decision in this matter is final and non-appealable.

17 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
18 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


