

**PROCEDURAL ORDER**

**BY THE COMMISSION:**


On May 21, 2007, the Arizona Corporation Commission ("Commission") issued Decision No. 69581, which approved long-term debt and a rate increase for Ash Creek Water Company ("Applicant" or "Company"). As a compliance matter, the Company was ordered to file, within 60 days of the effective date of the Decision, "copies of all executed loan documents certifying that the transactions have been completed."

On July 27, 2007, the Company filed a request for an extension of time, until September 21, 2007, to file the loan documents primarily due to Applicant's emergency interim manager undergoing emergency surgery. There has been no response from the Commission's Utilities Division ("Staff").

Accordingly, Staff should file a response.

IT IS THEREFORE ORDERED that the Commission's Utilities Division shall file a response to the request for an extension of time by September 17, 2007.


