You have added a surge charge of \$104.00. For hauling water; but no mention of how many tanks had to be hauled. All of Pine is being charged this way. Not only do I think this is unnecessary, But totally unfair \$160.00 water bill outrageous. Not only can we not afford this but we do not want to pay a company for water that we are not sure is being hauled. Someone needs to look into this matter and investigate this problem. I have been told by many residents of Pine that the truck just runs around Pine empty to look like water is being hauled. We need answers. Soon. Can you reply? Maybe something is being done? Considering all the money being made from just Pine residents you could drill a few more wells by now or put in some storage sheds. We are not happy at this time with our water company. Maybe some of you should come to Pine and see what its like to get water bills of this amount or not be able to water our yard, Flush toilets ect. Ect. We go out of our way to conserve water and Brookes slaps us for it. You haul one truck we all get charged. What a scam... I personally would like to see receipts for this water hauling. Considering we have no where else to get water what are we suppose to do. We would like some answers...It's not our fault you run out of water you agreed to supply by buying this water

Brookes has sent out a letter trying to explain why and how they are ripping us off. When reading this my first question is if half the month were on stage 3 and the other half were on 4 then why is all my water used being surcharged? Is all my water hauled? I don't think so...

And if all customers being charge the same then why don't our bills add up correctly? It says every customer pays the same by my calcs we are paying.

5/12 to 6/11 we used 5370 gals divide surcharge of \$88.64 by 5.37 1,000 gal. We are paying \$16.50 per 1,000 gal

6/11 to 7/09 we used 5550 gals divide surcharge of \$87.35 by 5.55 1,000 gal. We are paying \$15.73 per 1,000 gal

7/9/ to 8/10 we used 4390 gals divide surcharge of \$104.08 by 4.390 1,000 gal. We are paying \$23.70 per 1000 gal

We used less gals this month and charged more surcharge "What a concept" And on 4/14 to 5/12 you prorated us \$ 105.60 for use that we don't know it says we used 16,000 gals of water this is impossible.

Brook's example is if they are charged \$16.00 for every 1,000 gals

They charge each and ever customer \$16.00 for every 1000 gals used

They make up that \$16.00 charged on one customer what about the other 3,000 customers

Brooke's is making a killing on us.

Water Hauling Surcharge Fact Sheet

- Pine Water's tariff is based upon a series of Stages, which are based upon the storage levels within the company's system. When storage levels reach Stages 4 and 5, water hauling is required to supplement available water.
- The tariff requires hauling to prevent an outage when production or storage levels are in decline. Pine Water must continue to haul water until Stage 3 is reached for 48 consecutive hours, indicating that production is catching up with demand.
- Any water hauled is financed through Pine's Water Augmentation Surcharge, which consists of two components:
 - Cost of the supplemental water
 - Cost to transport the water
- To illustrate: if it costs \$16.00 for every 1,000 gallons of water hauled in a given month, the customer will be charged an additional \$16.00 for every 1,000 gallons of water used. Therefore, if the customer used 5,000 gallons, a hauling surcharge of \$80.00 would be added to the customer's bill.
- The monthly cost of the supplemental water and the cost to transport is divided by the total number of gallons used within the entire system for the month. Each customer is charged according to how many gallons used during the corresponding billing cycle which is why during some months the surcharge is lower than other months.
- Every customer pays the same rate per 1,000 gallons for hauling. That rate is applied to only the gallons used by each customer, which is why each customer's total hauling surcharge per month is different.
- A hauling surcharge will appear on the bill the month after hauling takes place and will be based on usage during the month water is hauled. In other words, when a surcharge appears on your new billing statement, the charge refers to the gallons used during the previous month.
- All hauling surcharge costs are submitted to ACC Staff before they are assessed to customers.
