PROCEDURAL ORDER

BY THE COMMISSION:

On May 17, 2007, Santa Cruz Water Company, L.L.C., and Palo Verde Utilities Company, L.L.C. (collectively "Global Utilities") filed with the Arizona Corporation Commission ("Commission") an application to extend their respective Certificates of Convenience and Necessity ("CC&N") in Pinal County, Arizona.

On June 12, 2007, Global Utilities filed its Compliance Status Report issued by the Arizona Department of Environmental Quality.

On June 15, 2007, Arizona Water Company ("AWC") filed an Application to Intervene ("Application"). No opposition was filed and AWC's Application was granted, by Procedural Order, on June 26, 2007.


On June 15, 2007, the Commission's Utilities Division ("Staff") filed an Insufficiency Letter in this matter.

On July 17, 2007, AWC filed a Motion to Consolidate ("Motion") the above-captioned dockets with Docket Nos. W-01445A-06-0199, SW-03575A-05-0926, and W-03576A-05-0926, stating the dockets involve common questions of law and fact.

On August 6, 2007, Global Utilities filed its Response to AWC's Motion to Consolidate and objected to the consolidation.

1 Staff has not filed a response to AWC's Motion to Consolidate the above referenced dockets.
2 IT IS THEREFORE ORDERED that Staff shall file a response to AWC's Motion to
3 Consolidate and address any objections raised in Global Utilities' Response on or before
4 September 21, 2007.


