I am writing to ask the Corporation Commission to continue their investigation into Brookes Utilities. As a homeowner in Strawberry I have been subject to numerous water outages. As with our neighbors in Strawberry we plan for these outages, including now having large barrels outside for extra water storage. Unlike the neighbors though, my son is handicapped, and frequently needs additional baths and toileting. One of the primary reasons we purchased a home in Strawberry is because this town has not had the water shortages of other Arizona areas. Knowing that we will always have adequate water supply is very important to us. The recent problems with the Brookes company seem to indicate that the owners of Brookes are not providing a service for the community but rather they are looking for additional ways to profit. Dependable water service should be a right, not a privilege.
