PROCEDURAL ORDER

BY THE COMMISSION:

On June 14, 2006, Beaver Dam Water Company, Inc. ("Beaver Dam" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("CC&N") to provide wastewater service in Mohave County, Arizona.

On July 14, 2006, the Commission's Utilities Division ("Staff") filed an Insufficiency Letter in this matter.

On August 21, 2006, Beaver Dam filed its Affidavit of Publication and an Amended Legal Description.

On September 15, 2006, Staff filed its second Insufficiency Letter.

On January 8, 2007, Beaver Dam filed its response to Staff's second Insufficiency Letter.

On April 25, 2007, Beaver Dam filed an amended Sewer Tariff Schedule and an Amended Legal Description.

On May 23, 2007, Staff filed its third Insufficiency Letter.

On June 25, 2007, Beaver Dam filed its response to Staff's third Insufficiency Letter.

On July 10, 2007, Staff filed a Sufficiency Letter in this docket indicating that the Beaver Dam has met the sufficiency requirements as outlined in the Arizona Administrative Code ("A.A.C").

On August 3, 2007, a Procedural Order was issued setting the hearing and other procedural deadlines in this matter.

1 On August 30, 2007, Staff filed a Motion to Extend Time to file its Staff Report from August
2 31, 2007 to September 7, 2007. Staff's Motion states that the applicant is agreeable to this extension.
3 Accordingly, Staff's Motion should be granted.

4 IT IS THEREFORE ORDERED that Staff's Motion to Extend Time to file its Staff Report
5 to September 7, 2007 is hereby granted.


6 IT IS FURTHER ORDERED that all motions to intervene shall be filed on or before
7 September 20, 2007.

8 IT IS FURTHER ORDERED that all other time frames set forth in the August 3, 2007
9 Procedural Order shall remain the same.

10 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 – Unauthorized
11 Communications) applies to this proceeding and shall remain in effect until the Commission's
12 Decision in this matter is final and non-appealable.

13 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
14 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
15 hearing.


