QWEST CORPORATION'S RESONSE  
TO STAFF'S MOTION FOR  
EXTENSION OF TIME TO FILE  
SETTLEMENT AGREEMENT  
TESTIMONY

Qwest Corporation ("Qwest") hereby responds to the Staff's motion for a two week extension of time to file Staff's Settlement Agreement testimony.

Staff's request will necessitate a revision of all subsequent procedural dates as well. Due to previously scheduled travel commitments of Qwest's counsel, an order which merely extends the testimony filing dates for the parties, but leaves the hearing date intact, will deprive Qwest's witnesses of the availability of Qwest's counsel to provide legal advice during the time Qwest's witnesses are preparing their responsive testimony, and would permit inadequate time for Qwest's counsel to prepare for the hearing.

Counsel for Joint CLECs has informed Qwest that he has a hearing the week of October 15. Therefore, Qwest proposes the following procedural schedule revisions as a consequence of

5 In view of Staff's representation that there are many complex and contested issues, a  
6 modification of the entire schedule is appropriate. Further, it is prudent in Qwest's view to  
7 schedule two days instead of just one.
