MOTION TO INTERVENE

Tucson Electric Power Company ("TEP") and UNS Electric, Inc. ("UNS Electric"), through undersigned counsel, and pursuant to A.A.C. R14-3-105, hereby move the Arizona Corporation Commission ("Commission") for an order allowing TEP and UNS Electric to intervene in the above captioned proceeding. In support hereof, TEP and UNS Electric state as follows:

- 1. TEP is an Arizona public service corporation that provides electric service to customers within the State of Arizona.
- 2. UNS Electric is an Arizona public service corporation that provides electric service to customers within the State of Arizona.
- 3. In this Docket, Arizona Public Service Company ("APS") has applied for consideration pursuant to A.R.S. § 40-252 to modify Decision No. 67744 relating to the self-build option (the "Application").
- 4. TEP and UNS Electric are directly and substantially affected by the outcome of APS' Application relating to the self-build option because it may set precedent or policy that could affect TEP's and UNS Electric's procurement practices.
- 5. No other party can adequately represent the interests of TEP and UNS Electric in this Docket. TEP's and UNS Electric's involvement in this case will not broaden the issues of APS' Application, nor will it unduly prejudice APS or any other interests.
