**NOTICE OF COMPLIANCE WITH  
DECISION NO. 68826**

Northern Sunrise Water Company ("Northern Sunrise") and Southern Sunrise Water Company ("Southern Sunrise") (collectively "Applicants") hereby submit this Notice of Compliance With Decision No. 68826 (June 29, 2006) ("Order"), which addresses the following two items: 1) the requirement that, by August 25, 2007, Applicants complete the improvements

1 listed in Exhibit B of the Order, as well as install an additional 30,000 gallons of storage for the  
2 Sierra Sunset system; and 2) the requirement that Applicants file with Docket Control by  
3 August 31, 2007 an annual off-site hook-up fee status report for the prior twelve month period.

4 On August 14, 2007 a Procedural Order was issued, extending the deadline to complete  
5 the system improvements listed in Exhibit B, and the addition of 30,000 gallons of storage for the  
6 Sierra Sunset system, to February 19, 2008.

7 Attached hereto as Exhibits 1 and 2 are reports on Water Hook-Ups for Northern Sunrise  
8 and Southern Sunrise, respectively. The reports show that for the period from February 19, 2007<sup>1</sup>  
9 through July 31, 2007 there were no hook-ups in accordance with Decision No. 68272  
10 (November 8, 2005), which imposed on the McLain water systems a moratorium on new  
11 customer hook-ups.

period from August 1, 2006 through February 18, 2007.


