PROCEDURAL ORDER

BY THE COMMISSION:

On May 21, 2007, the Arizona Corporation Commission ("Commission") issued Decision 69583, approving an Order to Show Cause Kacy J. Parker dba Jake's Corner Water System ("Respondent"). Decision No. 69583 directed the Hearing Division to "forthwith schedule further appropriate proceedings."

On August 21, 2007, the Commission's Utilities Division Staff ("Staff") filed a Request for Procedural Schedule. Staff states that although it appeared initially that the Respondent would voluntarily install the necessary storage tank without the need for further enforcement action by the Commission, those actions have stalled and Staff now seeks a hearing on the Order to Show Cause issued by the Commission. Therefore, Staff requests that a Procedural Order be issued establishing a procedural schedule for this matter.

IT IS THEREFORE ORDERED that a hearing shall be scheduled for October 9, 2007, at 10:00 a.m., at the offices of the Commission, 1200 West Washington, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that Staff shall file a Staff Report or pre-filed direct testimony by September 17, 2007.

IT IS FURTHER ORDERED that the Respondent shall file its responsive testimony by

2 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
3 Communications) applies to this proceeding and shall remain in effect until the Commission's
4 Decision in this matter is final and non-appealable.

5 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
6 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
7 hearing.


