ORDER

BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. In Decision No. 62279 (February 1, 2000), the Commission granted to Regal Diversified, Inc. dba Regal Telephone Company ("Applicant" or "Company") a Certificate of Convenience and Necessity ("Certificate" or "CC&N") authorizing it to provide resold long distance telecommunications services in Arizona.

2. On April 23, 2007, Applicant filed an application with the Commission requesting approval to cancel its CC&N to provide resold long distance telecommunications services and to cancel its tariffs in Arizona.

3. According to Staff's Report, the Applicant's application indicated that it intended to discontinue its discretionary prepaid, interexchange telecommunications service in Arizona on June 28, 2007.

4. Applicant is not conducting business or providing services to customers and has no facilities in Arizona.

5. The Applicant has never collected any advance payments, deposits, and/or

1 prepayments from customers.

2 6. Cancelling Applicant's CC&N poses no risk to customers because advance payments,
3 deposits, and/or prepayments were not collected.

4 7. On January 19, 2000, Applicant filed verification of procurement of a performance
5 bond in the amount of \$15,000. The performance bond is valid.

6 8. Staff recommends that Regal's performance bond as ordered in Decision No. 62279
7 (January 19, 2000) be cancelled.

8 9. Applicant has had zero complaints, inquiries, and opinions filed with the
9 Commission's Consumer Services Division.

10 10. According to the Commission's Corporation Division, Applicant is not in good
11 standing due to its failure to file its 2007 annual report and for failing to update its domestic address
12 with the Commission.

13 11. Staff recommends approval of the Applicant's application for cancellation of its
14 CC&N to provide resold local exchange services in Arizona.

15 12. The withdrawal of Applicant's tariffs are in the public interest.

16 13. Staff's recommendations are reasonable and should be adopted.

17 **CONCLUSIONS OF LAW**

18 1. Applicant is a public service corporation within the meaning of Article XV of the
19 Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

20 2. The Commission has jurisdiction over Applicant and the subject matter of the
21 application.

22 3. The cancellation of Applicant's CC&N is in the public interest.

2 IT IS THEREFORE ORDERED that the application of Regal Diversified, Inc. dba Regal
3 Telephone Company for cancellation of its Certificate of Convenience and Necessity to provide
4 resold long distance telecommunications services in Arizona is hereby, granted.

5 IT IS FURTHER ORDERED that the tariffs of Regal Diversified, Inc. dba Regal Telephone
6 Company are hereby cancelled.

7 IT IS FURTHER ORDERED that Regal Diversified, Inc. dba Regal Telephone Company's
8 performance bond should be cancelled.

9 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
