PROCEDURAL ORDER

**BY THE COMMISSION:**

On April 2, 2007, Arizona-American Water Company ("Arizona-American" or "Company") filed an application for a rate increase for its Sun City Water District.

On June 5, 2007, a Procedural Order was issued in this docket setting this matter for hearing to commence on January 7, 2008 and setting associated procedural deadlines, including a requirement for public and customer notice of the application and hearing by mail and publication.

On August 15, 2007, the Company filed a Motion to Amend Form of Notice.

On August 29, 2007, the Town of Youngtown ("Youngtown") filed a Motion to Intervene.

On September 7, 2007, the Company filed a Withdrawal of Motion to Amend Form of Notice.

No objections to Youngtown's Motion to Intervene have been filed and accordingly, Youngtown's Motion should be granted.

IT IS THEREFORE ORDERED that the Motion to Intervene by the Town of Youngtown is hereby granted.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized Communications) continues to apply to this proceeding and shall remain in effect until the Commission's Decision in this matter is final and non-appealable.
