MOTION FOR EXPEDITED HEARING

Matrix Telecom, Inc. ("Matrix") requests an expedited hearing on its Application for a facilities-based local exchange certificate of convenience and necessity. In particular, Matrix requests a prompt hearing to ensure that a recommended order and opinion can be prepared and considered at the Commission's October 11, 2007 open meeting.

To facilitate expedited hearing and consideration of the application, Matrix hereby: (i) agrees to order an overnight transcript of the hearing and (ii) waives the 10-day period to file exceptions. Moreover, upon receiving the procedural order setting forth the form of notice, Matrix will promptly publish notice of the hearing. Matrix anticipates that, based on typical practice, the notice will be published within three to four business days after the form of notice is provided to the newspaper.
