RE: ASHCREEK WATER COMPANY - MOTION FOR EXTENSION OF COMPLIANCE DEADLINE (DOCKET NOS. W-02494A-06-0561 AND W-02494A-06-0562)

In Decision No. 69581, dated May 21, 2007, the Arizona Corporation Commission ("A.C.C." or "Commission") approved the application of Ashcreek Water Co. ("Ashcreek") to modify its existing Certificates of Convenience and Necessity ("CC&N").

As part of Decision No. 69581, the Commission ordered that Ashcreek should:

"...file, within 60 days of the effective date of this Decision, with the Commission's Docket Control, as a compliance item in this docket, copies of all executed loan documents certifying that the transactions have been completed."

Staff contacted Mr. Bevan Barney, interim manager for Ashcreek, to determine the progress of the WIFA loan. In a September 12, 2007 conversation, Mr. Barney stated that the loan had been executed and the executed loan documents were currently in the mail to the Commission. Mr. Barney followed that conversation with a faxed document requesting that the Ashcreek extension of time be withdrawn. That document is attached to this filing.

On September 13, 2007, Staff received a docketed copy of the executed loan documents required in Decision No. 69581. Staff concurs with the request for withdrawal. Ashcreek is in compliance with the above requirement of Decision No. 69581.



On July 25 Ashcreek Water Company filed a request for an extension of time to file the required executed loan documents to comply with Decision #69581, page 13, lines 4-8:

"IT IS FURTHER ORDERED that Ashcreek Water Company is hereby authorized to engage in any transactions and to execute any documents necessary to effectuate the authorization granted hereinabove and file, within 60 days of the effective date of this Decision, with the Commission's Docket Control, as a compliance item in this docket, copies of all executed loan documents certifying that the transactions have been completed."

Corrective Action: The WIFA process has proceeded and I have mailed the executed loan documents required. Since this will satisfy the Compliance requirement, I respectfully request that the Request for and Extension of Time to File the Executed Loan Documents be withdrawn.
