MOTION TO EXTEND DEADLINE

On July 23, 2007, Double Diamond Utilities, Inc. ("DDU" or "Applicant") filed an application with the Arizona Corporation Commission ("ACC") for an extension of its Certificate of Convenience and Necessity (CC&N) to provide water and wastewater service for a master planned community known as The Ranch at White Hills in Mohave County.

On August 20, 2007, the Commission's Utilities Division ("Staff") filed an Insufficiency Letter in this docket.

On August 27, 2007, Applicant filed its Response to Staff's Insufficiency Letter.

On September 6, 2007, Staff filed a Sufficiency Letter in this docket indicating DDU's application had net sufficiency requirements as outlined in the Arizona Administrative Code ("A.A.C.").

On September 11, 2007, the Hearing Division issued a Procedural Order setting forth the procedural schedule for this matter. The order directs Staff to file its Staff Report in this matter on or before October 2, 2007.

It is Staff's position that this time frame is insufficient in which to prepare the Staff Report for this new water and sewer CC&N. Staff needs to issue at least one set, and most likely more, of data requests to Double Diamond Utilities. The responses to those data requests will be essential in Staff's analysis of the instant application. To that end Staff will need more time in which to exchange those data requests, review the data, and prepare a report.

WHEREFORE, Staff respectfully requests that the Hearing Division amend the

1 Procedural Order of September 11 to allow Staff at least until November 2, 2007, to file the Staff  
2 report. Staff notes that additional dates may need to be adjusted as well as a result based upon any  
3 adjustment to the due date of the Staff Report.
