PROCEDURAL ORDER

BY THE COMMISSION:

On July 30, 2007, the Arizona Corporation Commission ("Commission") issued Decision No. 69722. Decision No. 69722 remanded this case to the Hearing Division for further proceedings regarding whether Arizona Water Company should continue to hold a Certificate of Convenience and Necessity ("CC&N") at this time for the area depicted in Exhibit B to that Decision (the Cornman extension area).

On August 17, 2007, Cornman Tweedy 560, LLC ("Cornman") filed an Application for Rehearing and Reconsideration of Decision No. 69722. The Commission took no action thereon.

A Procedural Conference should be set to allow the parties to Decision No. 69722 an opportunity to discuss procedural matters related to the ordered remand proceeding, including a suitable hearing date and an associated procedural schedule.

IT IS THEREFORE ORDERED that a **Procedural Conference** shall be held in this matter on **October 5, 2007, at 10:00 a.m.**, or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized Communications) applies to this proceeding and shall remain in effect until the Commission's Decision in this matter is final and non-appealable.
