PROCEDURAL ORDER

BY THE COMMISSION:

On April 20, 2005, ValuTel Communications, Inc. ("ValuTel") filed with the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide resold long distance and resold local exchange telecommunication services.

On April 27, 2005, the Commission's Utilities Division ("Staff") sent its First Set of Data Requests.

On May 2, 2006, by Procedural Order, Staff was directed to file an update on this matter no later than May 19, 2006.

On May 30, 2006, Staff filed a request for an extension of time to further review the matter.

On June 1, 2006, by Procedural Order, Staff was granted an extension of time until July 17, 2006, to file its update.

On July 17, 2006, Staff filed an update and recommended that this matter not be administratively closed.

On December 13, 2006, Staff sent its Second Set of Data Requests to ValuTel.

On June 15, 2007, ValuTel filed additional information in support of its application.


On August 2, 2007, Staff filed its Staff Report in this matter, recommending approval of ValuTel's application.

1 On September 21, 2007, the Hearing Division initiated a telephonic conference and several
2 issues raised in Staff's Report were discussed.

3 IT IS THEREFORE ORDERED that Staff shall file a **Supplemental Staff Report** on or
4 before **September 28, 2007 discussing the issues raised during the telephonic conference.**

5 IT IS FURTHER ORDERED that any **objections to Staff's report** shall be filed no later than
6 **October 5, 2007.**
