SOUTHERN CALIFORNIA EDISON COMPANY'S
APPLICATION FOR PAYMENT OF FINE INTO AN ESCROW ACCOUNT

In Decision No. 69639, the Arizona Corporation Commission ("Commission") ordered that Southern California Edison Company ("SCE") pay a fine of \$4.8 million. SCE respectfully requests that it be allowed to pay that fine into an escrow account pending completion of the appeal of Decision No. 69639.


On June 6, 2007, the Commission entered Decision No. 69639 ordering, among other things, SCE to pay a \$4.8 million fine. On June 25, 2007, SCE filed an Application for Rehearing. That Application was deemed denied by operation of law on July 16, 2007. On August 10, 2007, SCE filed a complaint in the Maricopa County Superior Court

1 appealing that Decision. Pursuant to A.R.S. §40-254.F, Decision No. 69639 remains in
2 force during the appeal process.

3 SCE has had discussions with the Commission Staff about the administrative
4 logistics of payment of the fine and, after consultation with the Staff, respectfully requests
5 that the fine be paid into an interest bearing escrow account mutually acceptable to the
6 Commission and SCE. Those monies, including interest, could then be transferred into the
7 State of Arizona's general fund if Decision No. 69639 is upheld after completion of the
8 appellate process or returned to SCE if SCE prevails on appeal.
