LETTER OF DEFICIENCY

Dear Ms. Wicks:

In reference to your rate application received on August 31, 2007, this letter is to inform you that your application has not met the sufficiency requirements as outlined in Arizona Administrative Code R14-2-103. Staff has found a number of deficiencies with the rate application which are listed on a separate attachment. The 30-day sufficiency determination period will begin anew when the Company corrects the deficiencies and Docket Control receives original and 13 copies of the corrected pages.

You have 15 calendar days, or until October 15, 2007 to correct the deficiencies, or make other arrangements with Staff to remedy your rate application. If corrections or other arrangements are not made by that date, Staff will request the docket number be administratively closed. Docket Control will retain one copy of the original application for Commission records. You may file an original and 13 copies of an updated application at a later date.

List of Deficiencies

The specific items that have caused a finding of deficiency are as follows:

1. The application name is incorrect; the name submitted on the application is Livco Water and Sewer Company – Water Division. However, the CC&N's are separate; please amend your application to reflect the correct CC&N holder which is Livco Water Company on your cover page. In addition, please re-file the cover page under Docket No. W-02121A-07-0506, to avoid confusion in Docket Control.
2. On page 6 of the application the amount of gallons sold does not match the amount of gallons sold on page 18 of the application. Please reconcile.
3. In regards to supplemental Plant Schedule for page 13, page 2. Please indicate which plant additions occurred before June 30, 2006 and which occurred after June 30, 2006.
4. On page 19 of the application there is interest expense which was added to the total operating loss. Please correct. Further, please describe this transaction in more detail, as the Company currently has no Commission authorized loans.
5. The bill counts do not produce the test year metered revenues. Please provide Staff with the separate revenue amounts that each meter size bill count produces.
