19 **BY THE COMMISSION:**

20 Having considered the entire record herein and being fully advised in the premises, the
21 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

22 FINDINGS OF FACT

23 1. Sano Corporation, d/b/a Maryland West Apartments ("Applicant") has a Certificate of
24 Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT")
25 service in the State of Arizona pursuant to Decision No. 66996 (May 24, 2004).

26 2. On August 20, 2007, Applicant filed with the Commission an application for
27 cancellation of its Certificate. Applicant indicated that it no longer provides COPT service in the
28 State of Arizona.

3. Applicant stated to the Commission's Utilities Division Staff ("Staff") that Applicant
does not wish to have a hearing in order to cancel the Certificate.

4. Staff found that the Applicant does not have any outstanding compliance issues which
need to be addressed with the Commission.

5. Corporations Division of the Commission reports that the Applicant is in good
standing.

ORDER

IT IS THEREFORE ORDERED that the application of Sano Corporation d/b/a Maryland West Apartments for the cancellation of the Certificate of Convenience and Necessity to provide customer-owned pay telephone service shall be, and is hereby, approved.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
