PROCEDURAL ORDER

BY THE COMMISSION:

On March 11, 1999, the Arizona Corporation Commission ("Commission") issued Decision No. 61559 in the above-captioned matter. IT IS FURTHER ORDERED that, although comments in this matter will be taken through May 6, 1999, companies or other persons (including the Utilities Division) are requested to file written comments on or before April 29, 1999 in response to those comments filed on or before April 23, 1999.
