I AM IN RECEIPT OF A CERTIFIED MAIL LETTER FROM DEAN S. MILLER, INTERIM EXECUTIVE DIRECTOR OF THE ARIZONA CORPORATION COMMISSION REGARDING AN ORDER OF DISMISSAL OF RESPONDENTS WITHOUT PREJUDICE.

IT HAS BEEN OVER 10 YEARS SINCE MY INVOLVEMENT WITH INTERACTIVE TECHNOLOGIES WEST AND I ABSOLUTELY HAVE NO KNOWLEDGE OR BEEN APPRAISED OF THE OUTCOME OF THE COMMISSION'S INVESTIGATION OF MY COMPANY SINCE I AGREED TO CEASE AND DESIST THE ALLEGED OFFERING OF SECURITIES WITHIN THE STATE OF ARIZONA.

IF IT IS REQUIRED FOR ME TO BE PRESENT FOR THE MEETING, I AM NOT ABLE TO ATTEND. I AM ON WELFARE, CAN NOT AFFORD TO PAY FOR ANY KIND OF TRANSPORTATION AND AM HEAVILY MEDICATED WHICH LITERALLY MAKES ME A SHUT-IN AND NOT ABLE TO TRAVEL OR MAKE ARRANGEMENTS FOR A TRAVELING CARETAKER AT THIS SHORT A NOTICE.

TO REFRESH THE COMMISSION'S MEMORY, PRIOR TO ME OPENING MY DOORS FOR BUSINESS, I REQUESTED A HEARING BEFORE THE ARIZONA CORPORATION COMMISSION'S SECURITY DIVISION TO PRESENT MY BUSINESS PLAN AND ASK FOR THEIR GUIDANCE. I WAS GRANTED THAT MEETING AND MR. KYLE GILLMAN, THE GENERAL COUNSEL FOR THE HOME OFFICE, AND I MET WITH YOUR PEOPLE AND LEFT WITH THEIR BLESSINGS.

I DO NOT KNOW THE PROCEEDURES IN THIS MATTER, BUT I WOULD ASK THE COMMISSIONERS IF THEY WOULD GRANT THE RELEASE OF MY BELONGINGS THAT WERE TAKEN FROM MY BUSINESS AND HOME. I HAVE PERSONAL DOCUMENTS, INCLUDING PASSPORTS, VARIOUS WEAPONS THAT INCLUDE RIFLES, SHOTGUNS AND PISTOLS. THERE ALSO ARE COMPUTERS AND MAILING EQUIPMENT.
