PROCEDURAL ORDER

BY THE COMMISSION:

On April 24, 2007, Cordes Lakes Water Company ("Company" or "Applicant") filed with the Arizona Corporation Commission ("Commission") an application for an increase in its permanent rates and charges.

On May 23, 2007, the Commission's Utilities Division ("Staff") issued a notice of insufficiency pursuant to A.A.C. R14-3-103.

On July 6, 2007, Staff filed a letter indicating the Company's rate application was sufficient, and classifying the Company as a Class C utility.

On July 27, 2007, by Procedural Order, a hearing was scheduled for November 8, 2007, and other filing dates established.

The Staff Report and/or any direct testimony and associated exhibits to be presented at hearing on behalf of Staff were to be reduced to writing and filed on or before September 28, 2007.

Any direct testimony and associated exhibits to be presented at hearing on behalf of intervenors were to be reduced to writing and filed on or before September 28, 2007.

Any rebuttal testimony and associated exhibits to be presented at hearing by the Company were to be reduced to writing and filed on or before October 12, 2007.

Any surrebuttal testimony and associated exhibits to be presented by the Staff and/or intervenors were to be reduced to writing and filed on or before October 19, 2007.

Any objections to any testimony or exhibits which have been prefiled as of October 19, 2007, were to be made on or before October 26, 2007.

1 On September 13, 2007, Staff filed a Motion to Extend Time ("Motion") to file the Staff
2 Report. Staff requested an extension from September 28, 2007, until October 12, 2007, to file its
3 report with the following changes made to other filing dates:

- 4 • Rebuttal to be due on October 26, 2007;
- 5 • Surrebuttal to be due on November 1, 2007; and
- 6 • Objections to any testimony/exhibits to be due on November 5, 2007.

7 Staff indicated that the Company had no objections to its Motion, and the hearing date of
8 November 8, 2007, should remain unchanged.

9 On September 17, 2007, by Procedural Order, Staff's Motion was granted.

10 On October 10, 2007, Staff filed its Second Motion to Extend Time ("Second Motion") which
11 requests that Staff be given a further extension of time to file its report and/or testimony by five more
12 days, from October 12 to October 17, 2007. Staff states it needs additional time to complete its
13 analysis and does not indicate the Company's position on the Second Motion and requests the
14 remaining filing dates remain unchanged.

15 Under the circumstances, Staff's Second Motion will be granted, but a like amount of time
16 (five days) should be extended to the Company to file Rebuttal, with a slight change to the filing date
17 for Surrebuttal (by noon on November 1, 2007). The date for Objections should remain unchanged.

18 IT IS THEREFORE ORDERED that the Second Motion for an Extension of Time as filed by
19 the Utilities Division is hereby granted with the following corresponding filing changes: **Rebuttal**
20 **due October 31, 2007;** and **Surrebuttal due on November 1, 2007, at noon.**

21 IT IS FURTHER ORDERED that the date for **Objections** shall remain **unchanged.**

22 IT IS FURTHER ORDERED that the presiding Administrative Law Judge may rescind, alter,
23 amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by
24 ruling at hearing.
