PROCEDURAL ORDER

BY THE COMMISSION:

On September 24, 2007, Southwest Utilities Management ("SUM"), the interim manager of Valle Verde Water Company ("Valle Verde" or "Company"), filed an application on behalf of the Company, with the Arizona Corporation Commission ("Commission") for emergency rate relief and access to Water Infrastructure Finance Authority ("WIFA") assistance.

On August 3, 2007, Commission Utilities Division Staff ("Staff") filed a Complaint and Petition for Order To Show Cause ("OSC") against Valle Verde. (Docket No. W-01431A-07-0462). On October 9, 2007, Staff filed a Request for Procedural Conference to update the Commission on developments in the OSC proceeding. By Procedural Order of this same date, a Procedural Conference was scheduled in the OSC proceeding.

The emergency rate application purports to be needed in part to address some of the concerns identified in the OSC matter. Therefore, a Procedural Conference for the purpose of establishing procedures in the emergency rate proceeding should be set to commence simultaneously with that being set in the OSC matter.

IT IS THEREFORE ORDERED that a **Procedural Conference** for the purpose of establishing procedures to govern the emergency rate proceeding shall commence on **October 16, 2008, at 10:30 a.m.**, or as soon thereafter as is practical, at the Commission's offices, Room 218, 400 West Congress, Tucson, Arizona 85701. The parties may appear telephonically. The telephone

2 IT IS FURTHER ORDERED that that the Presiding Officer may rescind, alter, amend, or
3 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
4 hearing.


