To Whom It May Concern:

In its Decision No. 69707, dated July 18, 2007, in Docket Nos. T-03406A-07-0202 & T-20527A-07-0202, the Commission directed Integra Telecom Holdings, Inc. (Integra) to 1) notify the Commission that the transaction had closed; and 2) provide verification that it had notified the Arizona customers of Eschelon Telecom of Arizona, Inc., Mountain Telecommunications of Arizona, Inc. and Electric Lightwave, Inc. of the acquisition and financing. Specifically, the ordering paragraphs state:

“It is furthered order that Integra provide notice to the Commission within 30 days following the acquisition close proposed in this transaction.” (Decision 69707, Page 15, Line 11)

“It is further ordered that Integra file verification that the (customer) notice has been completed with Docket Control within 90 days of a decision in this matter.” (Decision 69707, Page 16, Line 7)

The acquisition of Eschelon Telecom, Inc. and its subsidiaries, by Integra, completed August 31, 2007. The parties mailed notice of the acquisition and financing to all their Arizona customers on September 17, 2007. Copies of those notices are enclosed for the record
