PROCEDURAL ORDER

BY THE COMMISSION:

On May 21, 2007, Wilhoit Water Company, Inc. on behalf of its Thunderbird Meadows System ("Applicant" or "Company") filed the following applications: an application requesting approval of retroactive financing in the amount of \$15,000 in Docket No. W-02065A-07-0306; an application requesting approval of financing in the amount of \$131,058 in Docket No. W-02065A-07-0307; and an application requesting approval for a permanent rate increase in Docket No. W-02065A-07-0312.

On September 19, 2007, the Commission's Utilities Division ("Staff") filed a Motion to Consolidate the three above-captioned proceedings because Staff believes that the administration of these cases could be more efficiently handled if the matters were combined into a single proceeding.

27 be completed on or before **November 5, 2007.**


1 IT IS FURTHER ORDERED that the Applicant shall file certification of publication as soon

3 IT IS FURTHER ORDERED that notice shall be deemed complete upon publication
4 notwithstanding the failure of an individual property owner or customer to read or receive the notice.

5 IT IS FURTHER ORDERED that the ex parte rule (A.A.C. R14-3-113 – Unauthorized
6 Communications) applies to this proceeding as the matter is now set for public hearing.

7 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
8 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


