PROCEDURAL ORDER

BY THE COMMISSION:

On June 6, 2007, the Arizona Corporation Commission ("Commission") issued Decision No. 69646 conditionally granting Spanish Trail Water Company ("Spanish Trail") and Saguaro Water Company ("Saguaro") (collectively "Companies" or "Applicants") joint application to transfer a portion of Saguaro's Certificate of Convenience and Necessity ("CC&N" or "Certificate") to Spanish Trail.

Decision No. 69646 ordered Spanish Trail and Saguaro to file with the Commission's Docket Control a Hook-Up Fee Tariff application for new residential and commercial customers within 90 days of the Decision.

On July 17, 2007, the Companies filed a Motion for Extension of Time. Therein, Applicants stated that as their service territories cover many thousands of acres, identifying the water production, storage and transmission facilities to serve future growth involves relatively complex engineering issues. The Companies further stated that developing estimates of the velocity and density of future development within their CC&N territories, which is necessary in order to estimate future infrastructure costs, has proven difficult. The Companies therefore requested an extension of time to file the ordered Hook-Up Fee Tariff application.

On September 10, 2007, the Commission's Utilities Division Staff ("Staff") filed a memorandum recommending approval of an extension of time to December 6, 2007 for the Companies to file the required Hook-Up Fee Tariff.

1 The Companies' request is reasonable and should be granted.

2 IT IS THEREFORE ORDERED that the filing deadline for the Hook-Up Fee Tariff ordered
3 by Decision No. 69646 is hereby extended to December 6, 2007.


