RESCHEDULE HEARING


Qwest Corporation does not object to rescheduling the hearing, but asks that the hearing be set over only one day, to Tuesday, October 30. The current scheduling order, which was issued prior to the Staff's testimony regarding the proposed settlement was filed, contemplated a multi-day hearing. The Staff's testimony was not as complex or as extensive as the parties had anticipated. This docket, which has been delayed several times for various good reasons, implements important national telecommunications policies, and should not be unduly postponed. Therefore, Qwest submits that the Staff's

scheduling conflict may be avoided by beginning the hearing on what was the second day of the schedule, with a reasonable likelihood of finishing the hearing in one day.
