PROCEDURAL ORDER

BY THE COMMISSION:

On May 21, 2007, Wilhoit Water Company, Inc. on behalf of its Yavapai Mobile Home Estates System ("Applicant" or "Company") filed with the Arizona Corporation Commission ("Commission") the following applications: an application requesting approval of financing in the amount of \$10,000 in Docket No. W-02065A-07-0308; an application requesting retroactive approval of financing in the amount of \$36,105 in Docket No. W-02065A-07-0309; and an application requesting retroactive approval for a permanent rate increase in Docket No. W-02065A-07-0311.

Pursuant to A.A.C. R14-3-109(H), because the three above-captioned proceedings are related and the rights of the parties will not be prejudiced, these cases should be consolidated for further disposition by the Commission into a single proceeding.

1 IT IS FURTHER ORDERED that notice shall be deemed complete upon publication
2 notwithstanding the failure of an individual property owner or customer to read or receive the notice.

3 IT IS FURTHER ORDERED that the ex parte rule (A.A.C. R14-3-113 – Unauthorized
4 Communications) applies to this proceeding as the matter is now set for public hearing.

5 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
6 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
