MOTION TO WITHDRAW
REQUEST FOR EXTENSION OF
TIME

On June 25, 2007, the Groom Creek Water User Association ("Groom Creek" "Applicant") filed an application requesting Arizona Corporation Commission ("ACC" "Commission") approval of financing and a corresponding rate increase. Currently, ACC Staff ("Staff") is processing the application. Staff had stated that it would file the Staff Report on October 25, 2007.

On August 31, Staff issued a data request to Groom Creek. Response was due September 10, 2007, but the Applicant was unable to provide the responses at that time. Applicant requested an extension until September 14, 2007. Staff agreed. Applicant did not provide its responses until September 25, 2007.

Due to the delay in receiving responses to these data requests, Staff required additional time in which to prepare the Staff Report. To that end, Staff filed on October 1st a request to extend the due date for the Staff report. However, it appears that, although a procedural order was issued in the companion case to this matter, no such procedural order was issued in the instant matter.

WHEREFORE, Staff respectfully withdraws its request to modify such procedural order.
