




Dear Customer:

Golden Shores Water Company ("Company") filed an Application with the Arizona Corporation Commission ("Commission") for an order authorizing the Company to incur \$286,200 in long-term debt. The application is available for inspection during regular business hours at the offices of the Commission in Phoenix, Arizona and the Company's offices in Golden Shores, Arizona.

Intervention in the Commission's proceedings on the application shall be permitted to any person entitled by law to intervene and having a direct substantial interest in this matter. Persons desiring to intervene must file a Motion to Intervene with the Commission which must be served upon the Company and which, at a minimum, shall contain the following information:

1. The name, address and telephone number of the proposed intervenor and of any person upon whom service of documents is to be made if different than the intervenor.
2. A short statement of the proposed intervenor's interest in the proceeding.
3. Whether the proposed intervenor desires a formal evidentiary hearing on the application and the reasons for such a hearing.
4. A statement certifying that a copy of the Motion to Intervene has been mailed to the Company.

On February 23, 2007, the Company filed an application for an increase in its rates and charges. Docket No. W-01815A-07-0117. The Commission consolidated this matter with the Financing Application, and scheduled a hearing to commence on November 28, 2007, at the Commission's offices located at **1200 West Washington Street in Phoenix, Arizona**. Due to certain delays, the parties agreed to suspend both applications, and the **November 28, 2007, 9:30 a.m.** hearing date was changed to a **public comment session**.

On September 26, 2007, the Company announced its intention to withdraw its Rate Application. The Company expects that the rate application will be withdrawn by order of the Commission in early October, 2007. However, the Company intends to move forward with its Financing Application. Therefore, the **November 28, 2007, 9:30 a.m.** public comment session remains open for customers who might wish to provide comment on the Company's financing application.
