PROCEDURAL ORDER

**BY THE COMMISSION:**

On June 21, 2006, Raymond R. Pugel and Julie B. Pugel, as trustees of the Raymond R. Pugel and Julie B. Pugel Family Trust, and Robert Randall and Sally Randall (collectively "Pugel

1 Complainants”), filed with the Arizona Corporation Commission (“Commission”) in Docket No. W-  
2 03512A-06-0407 a Complaint (“Pugel Complaint”) against Pine Water Company (“Pine Water” or  
3 “Company”). The Complaint seeks to delete property owned by the Complainants from Pine Water’s  
4 certificated service area based on the allegation that Pine Water is not able to provide satisfactory and  
5 adequate water service in a reasonable time and at a reasonable rate.

6 On September 25, 2006, Asset Trust Management Corp. (“ATM”) filed a similar Complaint  
7 against Pine Water in Docket No. W-03512A-06-0613 (“ATM Complaint”).

8 On February 23, 2007, James Hill and Sioux Hill, as trustees of The Hill Family Trust, filed a  
9 complaint (“Hill Complaint”) against Pine Water in Docket No. W-03512A-07-0100.

10 By Procedural Orders issued December 19, 2006 and April 3, 2007, respectively, the ATM  
11 Complaint and the Hill Complaint were consolidated with the Pugel Complaint.

12 Several days of hearing were conducted in this matter in August, 2007, and again on  
13 September 27 and 28, 2007. At the conclusion of the hearing on September 28, 2007, two additional  
14 hearing days were scheduled, for November 9 and 19, 2007. Due to a scheduling conflict, the  
15 November 9, 2007, hearing will be continued until November 19, 2007.

16 IT IS THEREFORE ORDERED that **the hearing scheduled for November 9, 2007 shall be**  
17 **continued and the hearing in this matter shall resume on November 19, 2007, at 9:30 a.m.**, at the  
18 offices of the Commission, 1200 West Washington, Phoenix, Arizona 85007. Additional hearing  
19 days will be scheduled at the conclusion of the November 19, 2007 hearing as necessary.

20 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
21 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
22 hearing.
