PROCEDURAL ORDER

BY THE COMMISSION:

A hearing in the above-captioned matter was held on August 28, 2007. At the conclusion of the hearing, a briefing schedule was established that had Opening Briefs due on October 24, 2007, and Responsive Briefs due on November 7, 2007.

On October 31, 2007, Qwest Corporation filed an "Unopposed Request for an Extension of Time to File Responsive Briefs," requesting an extension until November 21, 2007. Qwest requested the additional time in order to respond to the extensive Opening Briefs that were filed. Counsel for Qwest contacted counsel for Eschelon and Commission Staff and reports that neither party opposes the request.

No party will be prejudiced by the requested extension.


