PROCEDURAL ORDER

BY THE COMMISSION:

On March 29, 2006, Arizona Water Company ("AWC") filed a complaint against Global Water Resources, LLC, Global Water Resources, Inc., Global Water Management, LLC, Santa Cruz Water Company, LLC, Palo Verde Utilities Company, LLC, Arizona Global Water - Santa Cruz Water Company and Arizona Global Water - Palo Verde Utilities Company (collectively "Global" or "Respondents").

A number of filings have been made in this docket by the parties and procedural conferences have been conducted.

On September 28, 2007, the parties filed a Stipulation Regarding Schedule setting forth

1 proposed dates for filing of testimony and hearing.

2 By Procedural Order issued October 1, 2007, and in accordance with the parties' Stipulation,  
3 the hearing in this matter was rescheduled to begin on January 8, 2008, and various testimony filing  
4 timelines were established.

5 On October 25, 2007, AWC filed a Renewed Motion to Compel, Motion for Protective Order  
6 and Request for Accelerated Hearing of Same.

7 On October 31, 2007, AWC filed a Supplement to Its Renewed Motion to Compel.

8 On November 6, 2007, a telephonic procedural conference was conducted with the parties to  
9 discuss amendment of the testimony filing dates and the hearing date. All parties, including Staff,  
10 agreed to the revised schedule reflected in the following ordering paragraphs.

11 IT IS THEREFORE ORDERED that the **hearing shall be rescheduled to commence on**  
12 **January 23, 2008, at 10:00 a.m.**, at the offices of the Commission, 1200 West Washington, Phoenix,  
13 Arizona 85007. **The hearing shall be scheduled for five consecutive business days.**

14 IT IS FURTHER ORDERED that a **Procedural Conference shall be scheduled for**  
15 **November 20, 2007, at 1:30 p.m.**, at the offices of the Commission, to discuss any remaining  
16 discovery issues.

17 IT IS FURTHER ORDERED that **Supplemental Direct Testimony by AWC and Global**  
18 **witnesses shall be filed by no later than November 30, 2007.**

19 IT IS FURTHER ORDERED that **Staff's Direct Testimony shall be filed by no later than**  
20 **December 21, 2007.**

21 IT IS FURTHER ORDERED that **Rebuttal Testimony by AWC and Global witnesses shall**  
22 **be filed by no later than January 4, 2008.**

23 IT IS FURTHER ORDERED that **Staff's Surrebuttal Testimony shall be filed by no later**  
24 **than January 18, 2008.**

25 IT IS FURTHER ORDERED that a **Procedural Conference shall be scheduled for January**  
26 **17, 2008, at 1:00 p.m.**, at the offices of the Commission.

27 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized  
28 Communications) continues to apply to this proceeding and shall remain in effect until the

1 Commission's Decision in this matter is final and non-appealable.

2 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
3 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
4 hearing.


