**REQUEST TO EXTEND FILING  
DEADLINE FOR RESPONSES TO  
ISSUES LIST**

On October 9, 2007, a Procedural Conference was held in the above-captioned matter. At the Procedural Conference, Staff was ordered to develop a list of issues for the parties to address in this docket. On November 6, 2007, Staff filed its list of 45 questions and requested that responses to the questions be filed on or before December 21, 2007. The Arizona Local Exchange Carriers Association ("ALECA"), on behalf of its members, requests that the deadline for the filing of the responses be extended until February 1, 2008.

Although ALECA is interested in having this docket move forward as expeditiously as possible, the deadline for the filing of initial responses to the lengthy issues lists in the Commission's AUSF/Access dockets<sup>1</sup> is December 5, 2007 and the deadline for the filing of reply comments is January 4, 2008. ALECA is an active participant in the AUSF/Access dockets and many of the parties in the instant docket are also participants in the AUSF/Access dockets. ALECA will be devoting its time and resources over the next several weeks towards finalizing its initial responses and reply comments in these other consolidated dockets. Under the circumstances, a short extension of the deadline for the filing of the responses to the questions in the instant docket will
