NOTIFICATION OF
INTERVENTION

BY THE COMMISSION:

On October 12, 2007, Tucson Electric Power Company ("TEP" or "Company") filed pursuant to A.A.C. R14-2-1801 *et seq.*, its application for approval of its Renewable Energy Standard and Tariff ("REST") Implementation Plan.

On October 29, 2007, Phelps Dodge Mining Company ("Phelps Dodge") and Arizonans for Electric Choice and Competition ("AECC") filed an Application for Leave to Intervene in this matter.

Phelps Dodge states that it maintains facilities and operations that receive electric service from TEP, and that as a large industrial user will be directly and substantially affected by the REST Surcharge Tariff ultimately approved by the Commission. AECC states that it is a coalition of energy consumer, with members who are customers of TEP.

No party objected to the Requests to Intervene. The intervention of Phelps Dodge and AECC will not broaden the issues nor unduly delay the proceeding.

IT IS THEREFORE ORDERED that the request to intervene by Phelps Dodge and AECC is hereby granted.


