**BY THE COMMISSION:**

On June 28, 2007, the Arizona Corporation Commission ("Commission") issued Decision No. 69672, which approved West End Water Company's ("Company") application for an extension of its existing Certificate of Convenience and Necessity ("CC&N") in a portion of Maricopa County, Arizona. The Decision granting the extension of the Company's CC&N was conditioned on the Company's compliance with Findings of Fact Nos. 25 and 26 set forth in the Decision.

On October 19, 2007, the Company filed a Request for an Extension of Time to Comply with Decision No. 69672<sup>1</sup>, requesting that it be permitted to extend the time from December 31, 2007 until July 31, 2008, to file a copy of the developer's Certificate of Assured Water Supply ("CAWS"). The Company also stated the new deadline is consistent with the timetable set by the Arizona Department of Water Resources ("ADWR") for reviewing and approving applications for a CAWS.

As of the date of this filing the Commission's Utilities Division ("Staff") has not filed a response or recommendations regarding the Company's request. Accordingly, Staff should file a response or recommendations in this matter.


