

As a 20 year resident and property owner in Tonto Village and a customer of Tonto Village Water Co. (hereafter referred to as "Company:), I hereby request the right to formally intervene in the above referenced rate case that was docketed on December 27, 2007.

I am gravely concerned over the service charges, the amount and quality of the water delivered, and the level of resources available to me and our community. Moreover, I am concerned that the Company's customers and I are receiving incorrect, incomplete, misleading or contradictory information regarding the company's stated desire to transfer the Company's assets to the residents of Tonto Village made at a public meeting on January 27, 2006 in Tonto Village and called by the Standage family. Since that time actions proposed by the Company are contrary to their stated intention as well as contradictory to statements made to their customers and printed on the water bills. The residents have acted in good faith and it is imperative that intervention be granted so that all Company actions and correspondence can be seen and examined in full.




