STAFF RESPONSE TO ARIZONA SOLAR
ONE LLC'S REQUEST FOR WAIVER

On June 27, 2008, Arizona Solar One LLC ("Arizona Solar") filed with the Arizona Corporation Commission ("Commission") a request for the Commission to exercise its discretionary power to consider Arizona Solar's application for a Certificate of Environmental Compatibility without Arizona Solar first satisfying the 90 day prefiling requirement of A.R.S. § 40-360.02(B). The basis for Arizona Solar's request is that the power flow and stability analysis that is part of the 90 day plan is not yet complete.

Commission Utilities Division Staff ("Staff") has considered Arizona Solar's request for a waiver of the 90 day prefiling requirement. Based on review of the request, Staff believes that nothing in the request sets forth a compelling reason to deviate from the statutorily prescribed time frame set out in A.R.S. § 40-360.02(B) in this instance. Therefore, Staff opposes grant of Arizona Solar's request for waiver.


