PROCEDURAL ORDER

20 **BY THE COMMISSION:**

21 On May 2, 2008, Arizona-American Water Company ("Arizona-American" or "Company")
 22 filed an application for a rate increase for its Agua Fria Water District, Anthem Water District,
 23 Havasu Water District, Mohave Water District, Paradise Valley Water District, Sun City West Water
 24 District, Tubac Water District, Agua Fria Wastewater District, Anthem Wastewater District, and
 25 Mohave Wastewater District.

26 On June 2, 2008, the Commission's Utilities Division ("Staff") filed a Letter of Deficiency
 27 indicating that the application had not met the Commission's sufficiency requirements.
 28

1 On June 20, 2008, the Company filed its Response to Deficiency Letter and the above-
2 captioned Revised Application. The Revised Application does not include a rate increase request for
3 the Anthem Water District, the Anthem Wastewater District, or the Agua Fria Wastewater District.

4 On June 24, 2008, the Residential Utility Consumer Office ("RUCO") filed a Motion to
5 Intervene.

6 No objection to RUCO's Motion to Intervene has been filed, and accordingly, it should be
7 granted.

8 IT IS THEREFORE ORDERED that RUCO's Motion to Intervene is hereby granted.

9 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
10 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


