First, Mohave has not yet prepared its own Amended and Restated REST Plan and therefore intends to continue to operate under the umbrella of Arizona Electric Power Company's Amended and Restated Renewable Energy Standard Plan until a separate Mohave specific plan is filed and approved.

Second, Mohave will recognize wind generation projects while operating under its current plan.

Mohave trusts the forgoing clarifies its Compliance Filing dated March 19, 2008.


