PROCEDURAL ORDER

BY THE COMMISSION:

A hearing in the above-captioned matter was held on August 28, 2007. At the conclusion of the hearing, a briefing schedule was established that had Opening Briefs due on October 24, 2007, and Responsive Briefs due on November 7, 2007.

By Procedural Order dated November 5, 2007, the deadline for filing Reply Briefs in the above-captioned matter was extended until November 21, 2007.

On November 16, 2007, Commission Utilities Division Staff ("Staff") filed a request to extend the deadline until December 6, 2007. 
