PROCEDURAL ORDER

BY THE COMMISSION:

On October 5, 2007, the Staff of the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") filed a Complaint and Petition for Order to Show Cause ("OSC") against Total Call International, Inc., ("Total Call" or "Company") for failure to comply with the terms of the Certificate of Convenience and Necessity ("CC&N") issued to the Company on October 4, 2001, pursuant to Decision No. 64065 ("Decision").

On October 23, 2007, Total Call filed with the Commission its Response to Complaint and Petition for OSC.

On October 30, 2007, the Commission issued its OSC, directing the Company to appear before the Commission to explain, among other things, why it failed to comply with certain terms of the Decision, why sanctions should not be imposed for such failure, and why the Decision should not be declared null and void. It was also ordered that the Hearing Division schedule further appropriate proceedings.



3 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
4 of the Arizona Supreme Court and A.R.S. §40-243 with respect to practice of law and admission *pro*
5 *hac vice*.

6 IT IS FURTHER ORDERED that that the Presiding Officer may rescind, alter, amend, or
7 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
8 hearing.


