PROCEDURAL ORDER

BY THE COMMISSION:

On August 28, 2007, the Arizona Corporation Commission ("Commission") issued Decision No. 69887, a Complaint and Order to Show Cause ("Complaint" or "OSC") against the following named Respondents for failing to file their 2005 Utilities Division Annual Reports ("Annual Reports"):

5 Therein, the Commission ordered a hearing to be conducted at a date and time set by the
6 Hearing Division.

7 On September 7, 2007, by Procedural Order, a pre-hearing conference was scheduled for
8 November 19, 2007.

9 On September 21, 2007, a Respondent in this proceeding, Global Internetworking, Inc.
10 ("Global") filed, in response to the Commission's OSC, an application to cancel its Certificate. As a
11 result, Global's application was assigned a separate docket number, Docket No. T-04105A-07-0548.

12 On November 8, 2007, the Commission's Utilities Division ("Staff") filed a memorandum in
13 this proceeding which indicated that three of the above-named Respondents, Green Acres Water
14 Company ("GAWC"), Oatman Water Company, L.L.C. ("OWC") and Strawberry Water Company
15 ("SWC") had filed their 2005 Annual Reports and should be dismissed from the proceeding. Staff
16 further indicated that three other of the above-name respondents, Earland E. Cass, Global and Nickea
17 Communication, L.L.C. ("Nickea") had filed applications to cancel their Certificates, and should also
18 be dismissed from the proceeding.

19 On November 19, 2007, Staff appeared with counsel and the issues in the proceeding were
20 discussed.

21 Accordingly, GAW, OWC and SWC should be dismissed from the proceeding because they
22 have filed their Annual Reports. With respect to Mr. Cass, he should be dismissed from the
23 proceeding because of his filing of an application to cancel his Certificate. With respect to Nickea,
24 on October 30, 2007, the Commission issued Decision No. 69957 which cancelled its Certificate at
25 the Company's request. With respect to Global, its Certificate was cancelled pursuant to the terms of
26 Decision No. 66452 which was issued on October 24, 2003.

IT IS THEREFORE ORDERED that Green Acres Water Company, Oatman Water Company, L.L.C. and Strawberry Water Company be dismissed from the above-captioned proceeding since they have filed their 2005 Annual Reports.

IT IS FURTHER ORDERED that Earland E. Cass, Global Internetworking, Inc. and Nickea Communication, L.L.C. be dismissed from this proceeding for the above-stated reasons.

IT IS FURTHER ORDERED that Docket No. T-04105-07-0548 be administratively closed.


IT IS FURTHER ORDERED that a **hearing on the Commission's Order to Show Cause shall take place** with respect to the remaining Respondents **on February 14, 2008, at 9:30 a.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules of the Arizona Supreme court and A.R.S. § 40-243 with respect to practice of law and admission *pro hac vice*.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 – Unauthorized Communications) applies to this proceeding and shall remain in effect until the Commission's Decision in the matter is final and non-appealable.

IT IS FURTHER ORDERED that the presiding Officer may rescind, alter, amend, or waive any portion of this Procedural order either by subsequent Procedural Order or by ruling at hearing.


