PROCEDURAL ORDER

BY THE COMMISSION:

On March 20, 2007, Rancho Del Conejo Community Water Co-op ("Rancho Del Conejo" or "Company") filed a Financing Application.

On May 4, 2007, Rancho Del Conejo filed a Rate Application.

On May 25, 2007, the Commission's Utilities Division Staff ("Staff") filed a Letter of Insufficiency in the rate case.

On July 11, 2007, Rancho Del Conejo filed a Response to the Letter of Insufficiency.

On July 30, 2007, Staff filed a Second Letter of Insufficiency.

On August 8, 2007, Rancho Del Conejo filed a Response to the Second Letter of Insufficiency.

On September 17, 2007, Staff filed a Letter of Sufficiency indicating the rate application had met the sufficiency requirements of A.A.C. R14-2-103 and classifying the company as a Class D utility in Docket No. W-02102B-07-0273.

By Procedural Order dated October 9, 2007, the applications were consolidated upon Staff's Motion.

1 On November 1, 2007 and November 14, 2007, Rancho Del Conejo filed additional
2 information in support of its application.


3 Pursuant to the Arizona Administrative Code, the Staff Report was due November 28, 2007.
4 On November 28, 2007, Staff filed a Motion for an extension of time to file the Staff Report stating
5 that it requires additional time to review the above-captioned consolidated matter.

6 Staff's request is for a short extension that should not affect the timely disposition of this
7 matter. The Company provided additional information as recently as November 14, 2007. Under the
8 circumstances, Staff's request of an extra week is not unreasonable, and does not appear to warrant
9 an extension of the time clock. Any additional requests for additional time, however, may require
10 such extension.

11 IT IS THEREFORE ORDERED that Staff shall file its **Staff Report** in this matter no later
12 than **December 5, 2007**.

13 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
14 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


