7 A Temporary Cease and Desist Order and Notice of Opportunity for Hearing ("Notice")
8 was entered on May 8, 2002 against Bob's Cash Express, Inc. ("Cash Express"), Bob's Land
9 One, Inc. ("Lane One"), Challenge/Land USA, Inc. ("Challenge"), Arizona Digital Security
10 Tech, Inc. ("ADST"), American Dish Tech, Inc. ("ADT"), Robert H. Roberts ("Roberts"),
11 Donald P. Shoemaker ("Shoemaker"), Garrett L. Wright (aka Garrett Lee) ("Wright"), Dan
12 ("D.J.") R. Harper ("Harper"), Michael J. Sagnelli ("Sagnelli") and Joyce Goodman
13 ("Goodman") (collectively, the "Respondents").

14 With the exception of Sagnelli, the Respondents were duly served with copies of the
15 Notice.
