STAFF'S REQUEST FOR AN EXTENSION  
OF TIME TO FILE ITS STAFF REPORT

The Applicant, Broadweave Networks of Arizona, LLC ("Broadweave"), is seeking authority from the Commission to provide resold and facilities-based local exchange services and resold long distance service. Pursuant to the procedural schedule established in this case, Staff is required to file its Staff report on December 21, 2007.

During its review of the Application, Staff became aware of an issue that requires further investigation. After having received the Staff's Data Requests related to these issues, the Applicant stated that it desires a confidentiality agreement be signed before providing complete responses to Staff's inquiries. Staff is in the process of executing a confidentiality agreement with the Applicant at this time. Staff then may need additional time to follow-up on the responses provided by the Applicant.

Accordingly, Staff respectfully requests a three week extension of time, or until January 11, 2008, to file its Staff Report. The new filing date proposed by Staff should not affect the hearing date which is currently set for January 23, 2008.
