**STAFF REPLY TO APPLICANT'S  
RESPONSE TO STAFF MOTION FOR  
EXTENSION OF DEADLINE**

Arizona Corporation Commission ("Commission") Railroad Safety Section Staff ("Staff") hereby responds to Applicant Union Pacific Railroad's ("Union Pacific" or "Company") response to Staff's Motion for an extension of filing deadline. Union Pacific's response indicates that it opposes Staff's motion on the basis of the indefinite nature of the extension and recommends restricting the extension to only 30 days. Staff appreciates the Company's effort to accommodate Staff's scheduling difficulty by the recommendation of a finite time period. However, as was indicated in the original motion, Staff has not yet finalized an agreement with the prospective consultant and is consequently unable to commit to a fixed time. Therefore Staff continues to request an indefinite extension of time in this matter pending such time as Staff is able to proceed.
